- Personal Commitment to Spend time in Moldova

#### So How Did We Do?

- AMSoft Group The Company expanded to 42 employees while I ran HCSG and has taken on several projects for outside clients
- Valynteen Solutions:
  - The Company currently has 11 employees and will expand significantly with the launch of Legal Bistro
  - The first external client contract was executed on March 26, 2013 to build a web services platform for a discounted shipping company called Ship4Charities
  - Legal Bistro will launch in beta before April 8th

## Legal Bistro

- Online community where consumers post their cases anonymously and lawyers bid for the placement of their profile for case leads
- Currently our database is comrised of:
  - 1.4 million lawyer and law firm records
  - More than 650,000 email addresses
  - Approximately 29,000 law firm website addresses
  - 514,000 lawyer profiles 100,000+ lawyer photos and detailed biographical information
- Objective: Demystify the process for hiring a lawyer while using the power of the Internet to force lawyers to compete (I.e. Lending Tree for Legal Services Market)

#### What Have We Learned?

- Government instability has not affected our ability to do business in Moldova
- Low wage requirements; highly motivated and skilled (IT skills and English speaking Non IT) labor pool
- Extremely fast and reliable Internet speeds
- Attractive environment to develop VOIP Call Centers
- Transparency & corruption are still problems but are very manageable
- Local Partners interested in working to attract foreign opportunities to Moldova

#### The Global Future

- Currently working with the Peace Corp, Pro Business Nord,
  The U.S. Embassy and Alec Russo University to develop:
  - Business Incubator in Balti, Moldova with heavy emphasis on technology related businesses
  - Evaluating the formation of a Business Alliance designed to attract and support foreign companies interested in doing business in Moldova
    - Local Service Provider Partners IT Services, Legal & Accounting, Company Adminsitration, Banking, Turnkey Office Space, Office furniture, signage, etc.
    - Dues paying Membership from the United States (Affinity type program)
      - Membership fees would help to fund the incubator
    - Potential alliance with the local Chamber of Commerce

### Valynteen Solutions Future

- Two other pending external client projects
- Internally funded projects:
  - Build online roommate matching business for U.S. market
  - Build video content site (i.e. Getty Images; iPhoto) around a 48,000 hour film library produced over 25 years by Discover America show
  - Develop Animated Video production capabilities to serve
    U.S. market
