Amendments to the AmCham Bylaws



At point 5.6, subparagraph (3) shall read as follows:
“(3) Members may nominate themselves for the position of member of the Board of Directors or may be nominated by other members of the Association.”



At point 5.8, letter j), the text “which exceed the limit set out in point [5.20(c)]” shall be replaced with the text “the value of which exceeds the limits established through the internal regulations.”



At point 5.19, letter c), the text “limited to 20,000 lei” shall be replaced with the text “established through the internal regulations.”
