Bribery is one of the world's most destructive and challenging issues. With over US\$ 1 trillion paid in bribes each year, the consequences are catastrophic, reducing quality of life, increasing poverty and eroding public trust. Recognizing this, ISO has developed a new standard to help organizations fight bribery and promote an ethical business culture.

CIS region in general has very poor overall ranking on anti-corruption compliance. Economies focusing on extractive industries are even more exposed. Therefore, it is vital for companies operating in this market to identify and mitigate their exposure to corruption risks as well as implement effective internal controls.

The brand-new *ISO 37001 Standard on Anti-Bribery Management Systems* was published in October 2016 and quickly became one of the most efficient tools to help organisations prevent, detect and address bribery risks.



ISO HIGH LEVEL STRUCTURE

ISO 37001 Anti-bribery Management Standard sits within the high-level structure of ISO general management standards and guidelines.



The preparation of ISO 37001 Standard took more than 3 years and involved experts from 56 countries. It is the FIRST certifiable global anti-bribery standard.

ISO 37001 Standard is duly considered the best industry standard and widely recognised as a tool helping organisations of all size and complexity, NGOs, private and public establishments operating in challenging markets, as well Government institutions to strengthen their internal and external controls relating to anti-bribery management.

Certain organisations already started demanding ISO 37001 certification from their counterparties as a condition for business relationship. Likewise, some Governments (e.g. Singapore) are seeking to impose ISO 37001 compliance as a condition for getting public procurement contracts.


JOINTLY WITH WITHERS WORLDWIDE
